

CARLING CURRIE CUP 2022 TICKET GIVEAWAY COMPETITION RULES

28 JANUARY 2022 - 21 JUNE 2022

1. Introduction

- 1.1. This promotional competition (“**Competition**”) is run by The South African Breweries (Pty) Ltd (“**Promoter**”) and is open to all persons of 18 years or older, fully vaccinated against COVID-19 and resident in South Africa, except for (a) the directors, members, partners, agents, consultants or employees of the Promoter and their immediate families, (b) the directors, members, partners, agents, consultants or employees of any suppliers of any goods or services to the Promoter in respect of this Competition, or (c) directors, members, partners, agents, consultants or employees of the Promoter’s advertising and promotion agencies, associated companies, and participating outlet owners and staff.
- 1.2. The rules set out in this document constitute the rules which will govern the Competition (“**Competition Rules**”).
- 1.3. Participation in the Competition by all entrants (“**Participants**”) constitutes acceptance of these Competition Rules.

2. Competition Period

This Competition will run from 15h00 28 January 2022 until 21 June 2022 at 08h30, both dates inclusive, or until the Promoter provides a public notice that the Competition has ended, whichever is earlier (“**Competition Period**”). Entries will only be accepted during the Competition Period.

3. Competition Entry Process

- 3.1. To enter the Competition, each Participant must complete the following steps:
 - 3.1.1. dial the USSD line at *120*173#, call to be charged at a rate of 20 cents per 20 seconds, on a mobile device; and
 - 3.1.2. answer the following two questions after being prompted to do so:
 - 3.1.2.1. **Fully vaccinated**

The first question a Participant will be asked is, “are you fully vaccinated against COVID-19?”. If Participants answer “no”, they will be eliminated from the Competition. If Participants answer “yes” they will automatically receive the next question.
 - 3.1.2.2. **Choose your match**

Participants will then be asked, “which match do you want to win x2 tickets for?”

Participants must then choose one of the listed Carling Currie Cup match fixtures, as set out in Annexure 1.

- 3.2. The above steps must be completed before 08h30 on the day of the relevant random draw as set out in Annexure 1.
- 3.3. Entry is only valid through this medium.
- 3.4. A Participant can only enter the Competition once.
- 3.5. Participants are liable for their own data and voice charges in respect of their participation in the Competition as well as any verification process, which will be charged at a rate of 20 cents per 20 seconds.
- 3.6. Entry into the Competition, as well as the availability of the Prizes, shall be subject to any regulations issued in terms of Section 27(2) of the Disaster Management Act, 2002 (“**Regulations**”).

4. Description of Prize

- 4.1. The prize for this Competition is 2 (two) tickets to 1 (one) Carling Currie Cup match, which match was selected by a winning Participant, in accordance with Competition Rule 3.1.2.2 (the “**Prize**”).
- 4.2. The winners will be permitted to bring a maximum of 1 (one) guest attendee (in addition to the winner) to redeem the Prize. The winner and the guest attendee chosen by the winner to join in receiving the Prize, shall hereinafter, collectively be referred to as the “**Attendee(s)**”.
- 4.3. The Promoter will not pay for the travel costs of the Attendees. All Attendees are responsible for making their own arrangements to receive and enjoy the Prize. No person may win more than one Prize in this Competition.
- 4.4. There are 130 (One Hundred and Thirty) Prizes available to be won during Competition Period and each Prize has a value of approximately R200.00, with a total value of approximately R26,000.00.
- 4.5. No Prize, in whole or in part, can be transferred to any other person or exchanged for an alternate prize or for its cash value. A winner may not substitute him/herself with any other person.
- 4.6. The Promoter will send the Prize to the winners electronically, via email. Winners may need to print the tickets at their own cost before attending a match.

5. Winner Selection and Notification

- 5.1. The winners will be selected by a random draw process administered by Foneworx (Pty) Ltd (“**Foneworx**”). There will be a total of 13 (thirteen) random draws. The draws will take place as set out in Annexure 1 and each random draw will consist of all valid entries received within the week prior to the relevant random draw date.

- 5.2. A total of 10 (ten) winners will be selected at each random draw.
- 5.3. The winners will be notified by the Foneworx via cellphone and Foneworx will make 3 (three) attempts to contact the winners over a 2 (two) hour period.
- 5.4. The winners will be notified on the same day as each random draw.
- 5.5. If Foneworx is unable to contact a winner within the time period set out in 5.3 above, he/she will be disqualified and a substitute winner may at the discretion of Foneworx be selected, using the same winner selection process.

6. Winner Verification

- 6.1. Attendees must be over the age of 18 (eighteen) years old, fully vaccinated against COVID-19 and will be verified as complying with the Participant eligibility criteria set out in Competition Rule 1.1.
- 6.2. Attendees will be asked to provide confirmation of their vaccinations against COVID-19, and may access these records at <https://vaccine.certificate.health.gov.za>, and a copy of their identity document/passport/driver's license/proof of residential address in order to receive the Prize. The Promoter reserves the right to conduct the validation and verification process via automated means and/or any other means that the Promoter may deem necessary and by participating in the Competition, all Participants consent to the appropriate validation and verification measures that the Promoter may implement from time to time.
- 6.3. The Prize will only be awarded after successful verification of the winners. Failing successful verification of any winner, a substitute winner may be selected at the discretion of the Promoter.
- 6.4. The Promoter reserves the right to carry out audits in respect of any winners to verify their eligibility and/or the validity of the winners' entries. The Promoter may disqualify any winners if any fraud or cheating or related activity is suspected, including without limitation, through the manipulation of entries or otherwise falsifying data. All entries, participants or travel partners determined by the Promoter or their agents to be invalid or ineligible will forfeit all rights to any Prize and will not be compensated in any way.

7. Prize Forfeiture

- 7.1. Winners must communicate their full details to the Promoter or its agent as requested by the Promoter or its agent. Failure to do so may result in forfeiture of the Prize.
- 7.2. If a winner is unable to attend, receive or utilise (as applicable) the Prize then the entire Prize shall be forfeited. There will be no compensation, in any form, including, but not limited to monetary compensation and/or rescheduling, to any party, irrespective of the reason/s for the inability of that winner to attend, receive or utilise (as applicable) the Prize.

- 7.3. Time permitting and subject to the Promoter's approval, where a Prize is forfeited a substitute winner may be chosen in the same manner as the original winner was chosen.

8. General

- 8.1. All Participants must comply with the Regulations at all times and any non-compliance with the Regulations will result in automatic disqualification. It shall be the sole responsibility of the Participants to observe and comply with any and all restrictions imposed by the Regulations from time to time. All Participants indemnify and hold harmless the Promoter, their respective associated companies (directors, officers and employees) and agents, against any losses or damages arising from a breach of the provisions of the Regulations by such Participants and Attendees and the Promoter shall not in any manner whatsoever be liable for any transgressions by any Participant or Attendees in this regard.
- 8.2. The Attendees will be required to strictly abide by all COVID-19 protocols imposed at the relevant Carling Cup match for which the winner has won the Prize. A failure to do so by the Attendees may result in forfeiture of the Prize.
- 8.3. In the event of a dispute, the Promoter's decision is final and binding and no correspondence will be entered into.
- 8.4. The timelines stated by the Promoter or its agent must be adhered to. Failing adherence to any timeline, at any stage, may result in disqualification and forfeiture of the Prize in its entirety with no compensation to any party by the Promoter.
- 8.5. Each Participant, by participating in the Competition, acknowledges, agrees and expressly consents to the following:
 - 8.5.1. the Promotor may process the Participant's personal information, including in the form of names, telephone numbers, identity numbers and/or email addresses, during and after the course and scope of the Competition; and
 - 8.5.2. the Promotor may transfer the winning Participant's personal information, including names, telephone numbers, identity numbers and/or email addresses, to the relevant third parties in order to make any required travel, delivery or other arrangements, as may be applicable, during the course and scope of the Competition for utilisation of the Prize,

which processing and transfer shall take place in accordance with the provisions of the Protection of Personal Information Act 14 of 2013 ("POPIA") and any other applicable law, and for the purpose of giving effect to the Competition.
- 8.6. With the exception of Competition Rule 8.5 above, the Promoter will not share any personal information with any third party except where such disclosure is necessary to enable the Promoter to

provide, deliver or in any other way give effect to these Competition Rules and/or the Prize, where such disclosure is permitted by law and/or where consent to sharing personal information is obtained from the Participants by the Promoter. The Promoter will comply with the relevant data protection legislation, including POPIA.

- 8.7. A Participant may, by submitting a request at the following link <https://www.sab.co.za/content/data-subject-request-0>, request the Promoter to-
- 8.7.1. correct or delete personal information about the Participant in its possession or under its control that is inaccurate, irrelevant, excessive, out of date, incomplete, misleading or obtained unlawfully; or
 - 8.7.2. destroy or delete a record of personal information about the Participant that the Promoter is no longer authorised to retain.
- 8.8. The Promoter may make media announcements or publish the names and/or photographs of the winners without remuneration being made payable to the winners, provided that any such person may expressly elect to decline this by written communication to the Promoter.
- 8.9. Should the Prize not be available despite the Promoter's reasonable endeavours to procure the Prize, the Promoter reserves the right to substitute the Prize with another of equal value as determined in the Promoter's sole discretion and subject to availability. No person will be compensated in any way in this instance by the Promoter.
- 8.10. The Promoter will not be responsible for any costs, expenses or other liabilities incurred by the winners which are not expressly contemplated as part of the Prize.
- 8.11. These Competition Rules may be amended by the Promoter on public notice at any time during the Competition Period or thereafter. These Competition Rules will be interpreted by the Promoter only.
- 8.12. The Promoter reserves the right to alter, amend or cancel this Competition in whole or in part. Any alterations, amendments or cancellations will be interpreted by the Promoter only. In the event of an alteration, amendment and/or cancellation the Promoter will not compensate any individual for any reason whatsoever.
- 8.13. All Participants and winners indemnify and hold harmless the Promoter, its respective associated companies (directors, officers and employees) and agents, against any and all claims for any loss or damages, whether direct, indirect, consequential or otherwise, arising from any cause whatsoever connected to or arising out of their participation in any way in this Competition or their receipt, participation, ownership and/or use of the Prize. This indemnity is not intended to exclude any liability for any person which cannot be excluded under the Consumer Protection Act 68 of 2008.**

- 8.14. The Promoter shall not be responsible for any lost, damaged, corrupted, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending an entry will not be accepted as proof of receipt of such entry. The Promoters shall not be responsible for the failure of any technical element relating to this Competition that may result in an entry not being successfully submitted. The Promoter is not responsible for lost, damaged or delayed entries as a result of any network, computer or cell phone hardware or software failure of any kind. No applications from agents, third parties, organized groups or applications automatically generated by computer will be accepted. Entries will only be accepted if they comply with all entry instructions. Any form of network or systems manipulation including but not limited to Botnets, Sim Farms, Trojans, SMS malware may not be used when entering the Competition.
- 8.15. By participating in the Competition, each Participant gives the Promoter consent to: (i) market its products and campaigns to the Participant; (ii) conduct market research using personal information of the Participant which may be shared with third parties to enable the Promoter to develop appropriate marketing strategies in respect of its customers; and (iii) use the personal information and other details provided by the Participant during the Competition entry process for the purposes of facilitation of the Competition. The Participant may decline to provide or retract his/her consent by opting out via the opt out mechanism provided on the communications.
